




**Fig. 1.3. Invalid file size (0.00 kb) is provided.**


**Fig. 2.1. Broken Links are found in the website.**




**Fig. 2.2. Broken Links are found in the website.**




**Fig. 3.1. Several pages in the website are not responsive as they are not fitting to screen in smaller screen resolutions leading to horizontal scrolling & content overlapping.**




**Fig. 3.2. Several pages in the website are not responsive as they are not fitting to screen in smaller screen resolutions leading to horizontal scrolling & content overlapping.**




**Fig. 3.3. Several pages in the website are not responsive as they are not fitting to screen in smaller screen resolutions leading to horizontal scrolling & content overlapping.**




**Fig. 3.4. the navigation bar sub-menus could not be accessed in smaller screen sizes as on expanding the link menu the link in the heard menu is getting activated.**


**Fig. 5.1. Tables in some pages are not fully visible in the print format.**






**Fig. 8.1. Contrast Errors are found in the website.**




**Fig. 8.2. Contrast Errors are found in the website.**

**Fig. 9.1. Language change link is not clickable by mouse on increasing text size.**




**Fig. 10.1. Mechanism (button to pause, stop) auto updating content is not provided for auto updating content in the homepage of the website.**




**Fig. 11.1. The title of some pages are not complete. It only states the topic of the page without including the name of institute and country.**

**Fig. 11.2. The title of some pages are not complete. It only states the topic of the page without including the name of institute and country.**




